1. The schedule of Regular Meetings of the year 2016 annexed hereto, is hereby adopted and the Secretary of the Planning Board is directed to post, email, mail, and file said schedule as required by law.

2. For the purpose of the aforesaid Act, the BURLINGTON COUNTY TIMES be and is hereby designated as the official newspaper to receive notices of meetings schedules and revisions, and that the COURIER POST and CENTRAL RECORD are hereby designated as additional newspapers.

3. Persons requesting notices of meetings and schedules of meetings pursuant to Section 14 of the aforesaid Act shall pay the sum of Twelve Dollars (\$12.00) per Year to receive the same. In the event the request for meeting notices and schedules is less than the entire year, said charge shall be pro rated at the rate of One Dollars (\$1.00) per month. Notices of meetings and schedules may be emailed or faxed at no charge.
